## 2009 EHHA Annual Member Meeting

On March 31, 2009, the Emerald Hills Homeowners Association held its Annual Member Meeting at the Peninsula Covenant Center to hear about current issues of interest to the community and to elect five Association members, each to a two-year term, to the Association's Board of Directors.



The sixty plus residents who attended the meeting were treated to presentations from:

- ❖ Christina Kerby and Joseph Ortiz, from the San Francisco Public Utilities Commission, who updated the community on the Hetch Hetchy Water System Improvement Program;
- ❖ Lt. Murray "Randy" Randleman, Lt. Ken Jones, Sgt. Mike Otte, and Deputy Jerry Justice Randy, from the San Mateo Co Sheriff's office, who emphasized the importance of calling 911 to notify the authorities of suspicious individuals in our community;
- ❖ Sgt. Paul McCarthy from the California Highway Patrol, who explained traffic enforcement initiatives currently underway in our area; and
- ❖ long-time Emerald Hills resident and former San Mateo County Sheriff, Don Horsley, who announced his candidacy for the District 3 seat on the San Mateo County Board of Supervisors, representing the residents of Emerald Hills in county government.

All in all, a really impressive program!

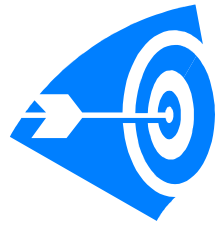
In addition to the speakers, three other VIPs attended the meeting: Diana Shu from San Mateo County Public Works; Steve Harper, former EHHA Board Member who holds the record for the longest term of service on the Board (16 years); and the Honorable Carol Groom, member of the San Mateo County Board of Supervisors from District 2. This was the first time in recent memory that a sitting member of the Board of Supervisors has attended a community meeting in Emerald Hills!

The official business conducted at the meeting included a financial report from Treasurer Tim Farrar, the year in review presented by President Michael Mangini, and the election of five Board Members for the 2009-2011 term. Although Board Members Adriana Botto, Frank Fraone, and Carla Rayacich chose not to run for another term, their service to the community was truly appreciated and acknowledged by all in attendance. Adriana Botto, in

particular, was recognized for her service as Board Secretary during which she brought a professional level of quality to both EHHA record keeping and production of the *Emerald Hills Review*.

After no nominations were received from the floor, the following individuals were elected to new two-year terms: Tim Farrar and Michael Mangini (incumbents), and new members Jay Roses, Carl Touhey, and John Raleigh. Jay Roses and Carl Touhey both bring professional experience in marketing that will enhance the Board's ability to produce the newsletter and stage special events, while John Raleigh's professional background in building and structural engineering will provide the Board with insight into interfacing with County governmental agencies such as Public Works, and Planning and Building.

The new Board has already set some ambitious goals for the upcoming year, which include making the *Emerald Hills Review* financially self-sufficient, achieving more widespread attendance at the monthly Board meetings by scheduling speakers on topics of community interest, and making the upcoming

## PLANNING AND BUILDING DEPARTMENT

### What's Up With Design Review in Emerald Hills? An Update

Erica Adams, Design Review Officer from the San Mateo County Planning Department, gave a presentation at the Board's well-attended June 10, 2009 meeting, outlining the current requirements for passing Design Review in Emerald Hills. Ms. Adams noted that as of January 2007, when the Design Review Committee was dissolved by the Board of Supervisors, applications for building permits requiring Design Review (i.e. those involving new construction or major remodels with significant exterior work) are now submitted directly to the Design Review Officer for approval. She detailed the steps applicants should follow to successfully navigate the Design Review hearing process, and highlighted those points in the process where neighbors could offer input into the final decision.

Responding to a question about results of the 2008 Design Review Community Survey, Ms. Adams said that because only 18% of residents responded to the survey, the Planning and Building Department would maintain the status quo for now. Board President Michael Mangini then added that community workshops

facilitated by the Peninsula Conflict Resolution Center had been budgeted by the County to take place in FY '09/'10, but that the economic downturn had resulted in those plans being put on hold.

In closing, Ms. Adams urged neighbors in Emerald Hills to talk with each other to achieve agreement on project details before permits are issued in order to avoid neighborhood discord arising after projects have begun.

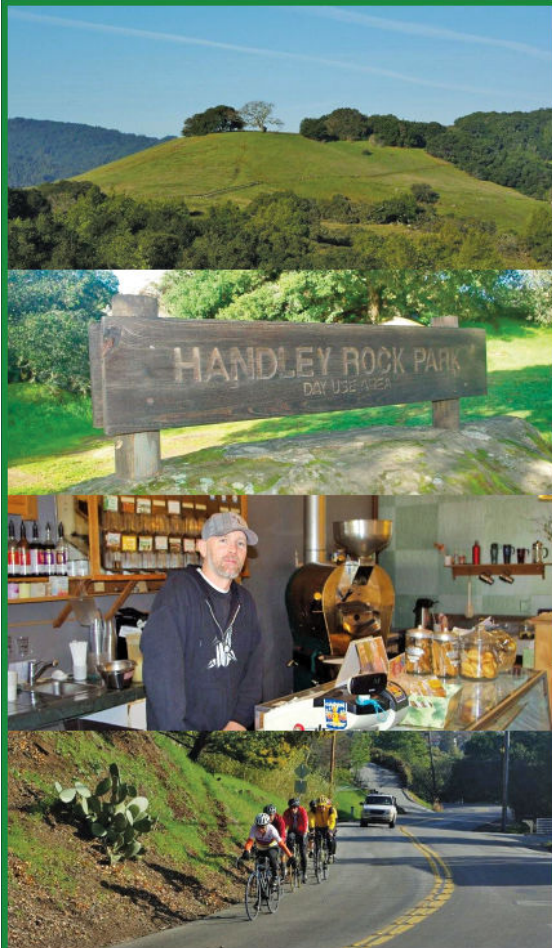


## DEPARTMENT OF PUBLIC WORKS

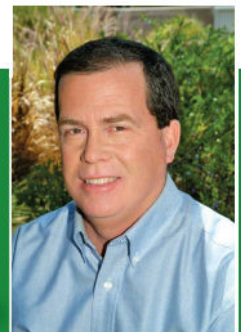

## **A Reminder about the 2009 Fire Season** **Woodside Fire Protection District** **Prevention Division**



The Woodside Fire Protection District is sending out a reminder that the *2009 Fire Season* is quickly approaching. With climatic and meteorological indicators suggesting a hot dry summer, the fire danger in our rural community is worrisome at the very least.

It is well recognized that our ability to live more safely in this environment depends upon our "pre-fire" preparedness. Measures taken before a wildfire occurs will improve the survivability of individuals, property, homes, our natural resources, and our open space.

As they do every year, Woodside Fire is urging residents to create a defensible space around their home by

- clearing brush 30 to 100 ft. away from structures
- mowing grass 4 to 6 inches
- planting low growing fire resistant vegetation
- cutting tree limbs 5 to 7 ft. off the ground
- trimming branches away from structures
- removing dead vegetation and flashy fuels such as dry grass 30 ft. inside the perimeter of property lines
- removing pine needles and other debris from rooftops

The Woodside Fire Protection District will be out in force in the upcoming months, inspecting homes to make sure property owners are complying with Government Code 51182 and the California Fire Code.

### **Protecting Your Home from a Brush Fire** **Danger Spots Around Your Home** **and What You Can Do to Eliminate Them**

#### **Problem: Untreated Wood Shake Roofs**

Untreated, wood shake roofs can easily catch fire from windblown sparks and embers, and are the number one cause of home losses in wildland fires.

**Solution:** If you re-roof, install a fire-resistant roof.

#### **Problem: Debris on Roof**

Tinder dry needles and leaves on your roof and in your rain gutters can easily catch fire and endanger your home.

**Solution:** Sweep your gutters and roof on a regular basis, especially during the dry, hot weather of the fire season

#### **Problem: Tree Limbs too Close to Your Chimney and Roof**

Tree limbs too close to your chimney can easily ignite and endanger your home. Dead limbs overhanging your home may ignite and spread a fire to your home

**Solution:** Trim all tree limbs that are within 10 feet of your chimney and remove all dead limbs overhanging your home or garage.

#### **Problem: No Screen on Attic and Foundation Vents**

Sparks or embers from an approaching wildland fire can get into your home through unprotected vents and ignite your home.

**Solution:** Cover your attic, roof, and foundation with vents that prohibit the intrusion of embers.

#### **Problem: No Spark Arrester on Your Chimney**

A spark from your chimney can ignite the surrounding vegetation or an untreated wood shake roof.

**Solution:** To ensure that you don't create your own spark hazard, screen your chimneys with 1/4 inch mesh noncombustible wire screening.

#### **Problem: Combustible Materials Stored Too Close to Your Home**

Firewood or other combustible materials stored too close to your home can ignite and cause a fire to spread to your home.

**Solution:** Store all combustible materials away from your home and keep the lids on your garbage cans.

#### **Problem: No Address Visible From the Street**

No visible address number will cause a delay in an emergency response. Remember the fire department cannot help you if they can't find you.

**Solution:** Make sure that your home can be quickly identified by ensuring that its address is clearly marked and visible.

#### **Problem: Overgrown, Dead Landscaping**

Overgrown, dead landscaping can ignite and endanger your home.

**Solution:** Maintain your landscaping. Trim and remove any dead vegetation. If you are re-landscaping, choose plants that are fire-resistant.

#### **Problem: No Defensible Space between Your Home and Vegetation**

Flammable vegetation too close to your home will make it almost impossible for firefighters to save your home in the event of a brush fire.

**Solution:** Vegetation management is key. In most areas, a safety zone should be cleared away from your home for a distance of not less than 30 feet. As the slope of your lot increases, additional clearance as far out as 100 feet or more may be necessary.



## Project Update: New Bay Division Pipeline One Step Closer to Construction

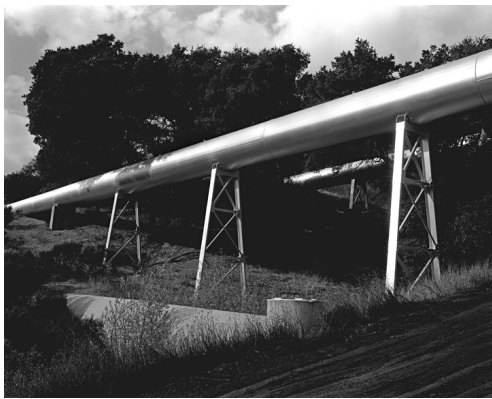

The Bay Division Pipeline Reliability Upgrade Project, or Bay Division Pipeline 5, slated for construction on the Peninsula and East Bay, is nearing a very important milestone in the coming weeks, with the expected certification of the Final Environmental Impact Report (EIR) on July 9, 2009. If the EIR is certified on July 9, the construction contracts, one for the East Bay, one for the West Bay, and one for the Tunnel, would be advertised in July and August.



The Project Team is finalizing formal agreements between the SFPUC and the cities and counties that construction would pass through. These agreements describe permits, construction coordination, public outreach, and SFPUC's restoration work in streets, parks, and schools following construction.



Construction is anticipated to take place between spring 2010 and spring 2012, and we should release a more precise construction schedule for Emerald Hills by February or March of next year. The construction team will have a local office on the Peninsula beginning in 2010, so we will be able to respond quickly to any questions or concerns in your neighborhood.

With the certification of the EIR and the completed agreements with the local jurisdictions, SFPUC would be one step closer to ensuring a reliable and earthquake-proof water supply for the Bay Area. We look forward to staying in touch as construction moves closer in the coming months and as always, we thank the EHHA members for including us in your community.

### CAUTION!

#### Spontaneous Combustion of Oil Rags



In recent years, the Woodside Fire Protection District has had an increase in residential fire loss attributed to spontaneous combustion of oily rags.

Oil soaked (including linseed, stain, paint and vegetable oil) rags that are not stored properly can permit oxidation. Spontaneous combustion can quickly occur igniting the rags and anything else near them.

It is extremely important to read the label of wood stains

and paint products to determine the content of that product, and any precautions that might be on the label. Other natural oils such as mineral oil, cottonseed oil, cod and other fish oil, present similar problems.

Rags used with these products should be stored by submersing them in a

water filled metal container with a fitted lid.

### San Mateo County Resources for Those in Need

Finding help for you or your family can be challenging, especially for those who are newly unemployed or have never before had trouble making a mortgage or rent payment. To help, San Mateo County has created an Internet site where you will find information and resources including food, emergency shelter, housing assistance, employment/unemployment, health information and mortgage, rent and credit counseling.

San Mateo County has also partnered with the Silicon Valley Community Foundation to provide financial assistance to non-profit organizations that are helping residents survive the current economic recession.

San Mateo County will distribute up to \$500,000 to organizations in the county as part of an Economic Urgency Assistance Program, which was approved by the Board of Supervisors in April. The Silicon Valley Community Foundation will award \$1 million to organizations that provide food and shelter in San Mateo and Santa Clara counties.

### SMC Forum

As California's budget crisis deepens, a new on-line forum offers San Mateo County residents the opportunity to voice their opinion about a proposal to convene a constitutional convention to overhaul state government.

The new on-line service, called **SMC Forum**, includes information about California's government and background on the call for a constitutional convention. Backers of the proposal are convinced California government needs fixing to improve accountability and to avoid crisis-driven decision-making.

Despite the difficult economic environment, the Association has recorded donations totaling \$2,255 from 48 residents so far this year, and had almost \$5,700 in the bank at the beginning of June (before the costs of producing this newsletter). Our current bank balance represents a significant improvement on the position earlier this year, due to a combination of donations received in response to the last newsletter, economies made on expenditure for the annual member meeting, and new revenues from advertising in the newsletter.
